Rajasthan's Key Role in "Compliance Reduction and **Deregulation'' Under Ease of Doing Business**

\bigcirc Why in News?

Cabinet Secretary Dr. T.V. Somanathan reviewed the work done under the "Compliance Reduction and de-regulation" agenda via video conference with Chief Secretaries across the country.

- Rajasthan has implemented several transformative reforms, demonstrating its commitment to strengthening the ease of doing business ecosystem:
- To promote the MSME sector, the state has simplified the change of land use process by amending Rule 90A, reducing the time limit from 60 to 30 working days. After this time limit, automatic approval has been introduced. This will reduce project delays and accelerate the establishment of new enterprises.
- In the area of pollution control The time limit for third-party certification for Consent to Establish and Consent to Operate has been reduced from 120 days to 21 days for MSMEs and 60 days for Red/Large category enterprises.
- The Pollution Control Board has introduced system-generated auto-renewal of CTOs across all categories based on self-certification.
- employee limit under the Rajasthan Shops and Commercial Establishments Act, 1958, has been increased from zero to 10, reducing the compliance burden on micro enterprises.
- The state has also implemented third-party fire inspectors and extended the validity period of fire NOCs, facilitating fire safety compliance.
- The state's single-window system, 'RajNivesh', has been upgraded with a chatbot, which integrates information from various departments to provide real-time automated assistance to investors.

Why in News?

Lal Sharma met with Union

Skill Development and Entrepreneurship, and Minister of State for Education Shri Jayant Chaudhary in New Delhi.

- Discussions were held regarding the progress of the Ferozepur Feeder Relining and Ram Jal Setu Link Project.
- In the interest of farmers, the tower base compensation rate has been increased to 400 percent of the DLC rate, while corridor compensation has been fixed at 30 percent in rural areas, 45 percent in municipal areas, and 60 percent in municipal corporation areas.
- The meeting held meaningful discussions on strengthening power evacuation, given the immense potential in Rajasthan to meet India's solar energy targets.
- AT&C losses are steadily decreasing. Similarly, the Jaipur and Ajmer Discoms have now fallen below the 15 percent level. Additionally, the pace of implementation of the RDSS scheme has been improved.

Other Key Points:

■ The Firozpur Feeder Relining Project is a vital water and irrigation infrastructure restoration project for Rajasthan and Punjab. The highlights of the project are as follows:

Project Objective

- The Firozpur Feeder is a major canal that originates from the Harike Barrage in Punjab and supplies water to the Gang Canal and other canal systems in Rajasthan's Sri Ganganagar, Hanumangarh, and other districts.
- Its lining had deteriorated over the years, leading to water leakage, waterlogging, poor flow, and uneven water distribution.
- 1960s: Construction of the Firozpur Feeder was completed.
- April 24, 2025: The 158th Advisory Committee of the Central Water Commission approved the project.
- 2027 (target): Complete construction in two years; capacity increased from 11,192 cusecs to 13,842 cusecs.

Sanjay Agarwal appointed Director General of Law and Order

The Rajasthan government has created a new post of Director General (DG) of Law and Order in the police department on November 14, 2025. Sanjay Agarwal is the first officer to be appointed to this post.



Key Points:

■ Rajasthan Police Chief (DGP) Rajiv Kumar Sharma issued an order assigning DG Agarwal the responsibility of three wings. Agarwal was previously responsible for law and order, the RAC Armed Battalion, and the SDRF. However, in addition to these wings, he has also been given the responsibility of supervising cyber crime and technical services.

Key Points:

Reason for By-Election:

BJP MLA from Anta Assembly seat, Kanwarlal Meena, had his membership revoked on May 1, 2025, after he was sentenced to three years in prison in a 2005 case.

Provisions for Cancellation of Membership:

- Under the RPA Act, 1951: 1.
- Section 8(3) Representation of the People Act, 1951: If an MLA (MP/MLA) is sentenced to a minimum of two years or more for any offense, his membership ceases from the date of conviction and he remains ineligible to contest elections for six years after the completion of his sentence.





- Section 8(4) (now abolished): Previously, a three-month respite was granted upon appealing a sentence in a higher court. However, this was declared unconstitutional in the 2013 Supreme Court case of Lilly Thomas, resulting in the termination of membership upon conviction, even if the appeal is pending.
- 2. Important Supreme Court Decisions:
- Lily Thomas vs Union of India (2013): Membership in Parliament or Legislative Assembly ceases immediately upon conviction. Now, membership is terminated even if the appeal is pending.

Mudh-Nyoma Airbase

- Why in News?
- India operationalized the Mudh-Nyoma Airbase in Ladakh, enhancing its defense preparedness along the Line of Actual Control (LAC) with China.
- **Key Points:**
- Location: The airbase is located at Nyoma in the Leh district of eastern Ladakh at an altitude of 13,700 feet (4,200 meters), making it one of the highest combat-capable airfields in the world.
- **Construction:** Border Roads Organisation
- Significance: Its proximity to the LAC provides India with significant strategic and military advantages, enabling rapid response, force projection, and advanced surveillance in sensitive areas such as the Depsang Plains, Pangong Tso, and Chushul Valley.
- Fourth major airbase in Ladakh: It will complement the Leh, Kargil, and Thoise airbases.


India and Nepal Relations



India and Nepal signed an agreement to enhance trade relations. India and Nepal have amended the Transit Treaty to facilitate rail-based cargo movement between Jogbani in India and Biratnagar in Nepal.

- This liberalization extends to major transit corridors Kolkata-Jogbani, Kolkata-Nautanwa (Sunauli), and Visakhapatnam-Nautanwa (Sunauli).
- Objective: To strengthen multimodal trade links between the two countries and promote Nepal's trade with third countries.









Saranda Forest

- **₩** Why in News?
- The Supreme Court directed the Jharkhand government to declare the ecologically rich Saranda Forest a wildlife sanctuary.
- **Key Points:**

About Saranda

- The Saranda Forest in Jharkhand is Asia's largest sal forest, spanning approximately 820-900 square kilometers. Its hilly terrain makes it known as the "Land of Seven Hundred Hills."
- The forest is part of the Chotanagpur biogeographic region and forms a natural landscape continuum with the forests of Odisha and Chhattisgarh.
- Major rivers flowing through the region include the Karo, Koina, and Lalour.
- Rare vegetation, palms, wild bananas, ferns, and piper species are found here.
- It is home to critically endangered species, including the endemic sal forest tortoise, four-horned antelope, Asian palm civet, and wild elephant.
- It is home to the Ho, Munda, Oraon, and allied tribal communities, whose livelihoods and cultural traditions are intrinsically linked to forest produce.
- It also holds 26% of India's iron ore reserves.

Climate Financing Targets

Why in News?

India clarified that the lack of climate financing is a major obstacle to achieving climate action goals.

- The 30th Conference of the Parties (CoP30) to the United Nations Framework Convention on Climate Change (UNFCCC) is being held in Belém, Brazil.
- During this conference, India issued statements on behalf of the BASIC and the Group of Like-Minded Developing Countries (LMDCs), highlighting the importance of climate financing.
- Members of the BASIC Group: Brazil, South Africa, India, and China. **Internationally Agreed Climate Financing Targets**
- Baku to Belém Roadmap 1.3 T (trillion) Target: At UNFCCC-CoP29, States Parties agreed on a new collectively quantified target. This includes a target of mobilizing a minimum of \$300 billion annually for developing countries, to be achieved by 2035.
- This also includes a broader target of increasing external financial assistance to \$1.3 trillion annually by 2035.
- Glasgow Climate Agreement: Under this, developed countries pledged to provide \$40 billion in financial assistance to developing countries for climate adaptation by 2025.





Declaration on Information Integrity on Climate Change

- Why in News?
- The Global Initiative for Information Integrity on Climate Change issued the Declaration on Information Integrity on Climate Change at COP-30.
- **Key Points:**
- Initiative Launch: This initiative was announced at the G20 Leaders' Summit in 2024. It is a dedicated multilateral collaboration between countries and international organizations. Its objective is to fund research and action that promotes information integrity on climate-related issues.
- It has also established a Global Fund for Information Integrity on Climate Change.

Aurora



■ Cannibal solar storms have caused aurora events in North America, Australia, and others.

Key Points:

■ Cannibal solar storms are powerful space weather phenomena. They occur when two or more solar storms collide and merge. This results in a more powerful storm, which affects GPS and electrical systems.

Aurora

- An aurora is a natural light phenomenon visible in the night sky, usually occurring only in the lower polar regions.
- The aurora occurs when atoms in the upper atmosphere interact with charged particles (electrons and protons) from the solar wind.
- Near the North Pole, it is called the aurora borealis. Near the South Pole, it is called the aurora australis.

New Royalty Rates for Critical Minerals

Why in News?

The Union Cabinet has approved specifying/revising the royalty rates for four critical minerals - cesium, graphite, rubidium, and zirconium - to promote domestic production.

Key Points:

Critical Minerals

- These are essential for economic development and national security, and a lack of availability of these minerals or the concentration of extraction or processing in certain geographic locations could potentially lead to "supply chain vulnerabilities and even supply disruptions."
- In 2023, the Center identified 30 critical minerals, including lithium, cobalt, nickel, graphite, tin, and copper, as essential for the country's economic development and national security.

Royalty Rates

- The royalty rate is the fee charged by the government on mining companies for extracting minerals from the earth.
- Royalty rates are governed by the Mines and Minerals (Development and Regulation) Act, 1957 and the Mineral Concession Rules, 1960.
- These laws empower the central government to fix and revise royalty rates from time to time, after consultation with state governments.

Global Carbon Budget 2025



Recently, the Global Carbon Project released the Global Carbon Budget 2025 report. According to this report, India's carbon emissions are projected to grow at a slower pace of 1.4% in 2025. This is attributed to the cooling effect of the monsoon and the growth of renewable energy.

- India will be the third-largest carbon emitter in 2024. India emits 3.2 billion tons of carbon annually, surpassed only by the United States (4.9 billion tons) and China (12 billion tons).
- Per capita carbon emissions in India are 2.2 tonnes annually.
- Major contributor: Coal is the major fuel type contributing to India's emissions.
