## RAJASTHAN



### Wooden Handicraft Common Facility Center: Jodhpur



#### Why in News?

- Recently, Rajasthan's Industry and Commerce Minister, Colonel Rajyavardhan Rathore, inspected the newly constructed Wooden Handicraft Common Facility Center in Jodhpur.



#### Key Points:

- Cost:** ₹1800 lakh
- Construction:** Jointly by the Central and Rajasthan governments.
- This center will provide state-of-the-art resources to artisans and entrepreneurs who lack the capacity to make large investments.
- This state-of-the-art center has been designed to equip Rajasthan's renowned wooden handicraft industry, especially the furniture manufacturing sector, with modern technology, higher production efficiency, and global competitiveness.

- **Note:** To promote exports under the Rajasthan Investment Promotion Scheme (RIPS) 2024, the state government is providing a 25 percent freight subsidy, which will reduce export costs and increase demand for Rajasthan's products in foreign markets.
- It is known that the World Craft Council (WCC) has declared Jaipur as 'World Craft City'.

## Facts for Prelims:

### Rajasthan Handicraft Policy, 2022

- On August 27, 2022, the Rajasthan Cabinet approved the "Rajasthan Handicraft Policy 2022."
- **Objective:** To develop the handicraft sector and empower approximately 600,000 artisans and craftsmen working in this sector.
- A state-level monitoring committee, led by the State Industries Department, has been formed to ensure the successful implementation of this policy.

### Key Provisions:

- The state government will bear 100 percent interest on loans of up to ₹3 lakh taken by artisans and provide group insurance to self-help groups working in the handicraft and handloom sectors.
- Cooperative societies of handloom weavers and artisan societies that are setting up permanent marketing centers for sales will receive 50 percent government assistance of the total cost.
- An online platform has been developed by the government to help artisans sell their products. Government departments will be able to purchase products worth up to ₹10 lakh from registered artisans through the e-marketplace without tendering.

### Why in News?

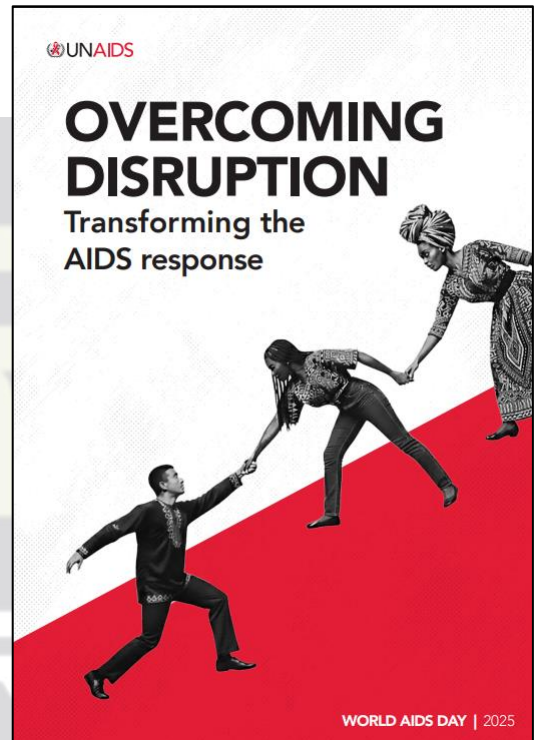

- The Government of India's flagship programme for AIDS prevention is the National AIDS and STD Control Programme (NACP).
- This programme is currently in its fifth phase, focusing on targeted interventions, free treatment, awareness campaigns, and a strong legal framework to combat stigma.
- The National AIDS Control Organisation (NACO) under the Ministry of Health and Family Welfare coordinates the multi-sectoral national strategy.

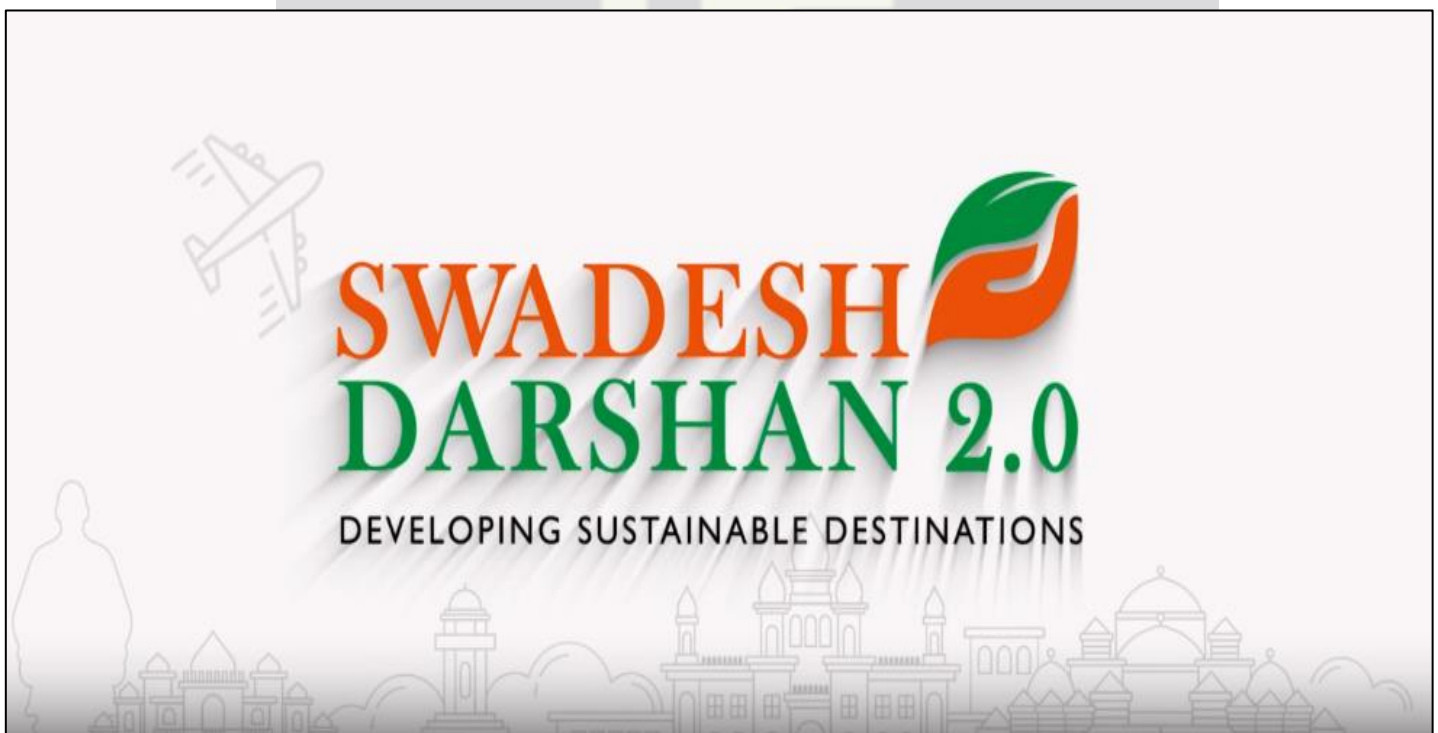

## ₹180 crore to Rajasthan under Swadesh Darshan Scheme 2.0



### Why in News?

- Recently, the Union Ministry of Tourism approved ₹180 crore for the development of four religious sites in Rajasthan under the Swadesh Darshan Scheme 2.0.



### Key Points:

#### Four religious sites in Rajasthan:

- **Bundi:** ₹21 crore 65 lakh to enhance the spiritual experience and promote religious tourism in Keshoraipatan.
- **Sikar:** ₹87 crore 87 lakh for the development of Khatu Shyamji Temple.
- **Bikaner:** ₹22 crore 58 lakh for the development of Karni Mata Temple.
- **Bhilwara:** ₹48 crore 43 lakh for the development of Malaseri Dungri, the birthplace of folk deity Devnarayan ji.

## Facts for Prelims:

### Swadesh Darshan Scheme:-

- **Launched:** In 2015 by the Ministry of Tourism.
- It is a 100 percent centrally funded scheme.
- Under this scheme, the Ministry of Tourism provides financial assistance to state governments, union territory administrations, or central agencies for the development of tourism infrastructure in the country.
- **Swadesh Darshan 2.0:** The Ministry of Tourism has revamped the Swadesh Darshan Scheme as Swadesh Darshan 2.0 (SD2.0) for the development of sustainable and responsible tourism destinations, covering tourism and allied infrastructure, tourism services, human capital development, destination management, and promotion, supported by policy and institutional reforms.

### Other important points:

- The Government of India launched the 'Special Assistance to States for Capital Investment Scheme' with the objective of developing historical tourist destinations and branding and marketing them globally.
- Under this scheme, 40 projects were approved in 23 states during the financial year 2024-25.
- Under the scheme, Rs 49.31 crore was approved for the development of Amer and Nahargarh forts in Rajasthan and Rs 96.61 crore for the development of Jal Mahal.

#### Key Points:

##### Hornbill Festival

- Held every year in the first week of December at Kisama near Kohima, it is a vibrant cultural presentation of all the Naga tribes.
- It was conceived in 2000 to promote unity and preserve ethnic heritage.

### UNESCO Executive Board



#### Why in News?

- India has been re-elected to the UNESCO Executive Board for the term 2025-29.



#### Key Points:

##### UNESCO Executive Board

- It is one of the three constitutional organs of the UN agency (the other two being the General Conference and the Secretariat) and is elected by the General Conference.
- It operates under the authority of the General Conference.
- It comprises 58 Member States, each serving a four-year term.

### Private Sector Entry into India's Nuclear Sector



#### Why in News?

- Prime Minister Narendra Modi has stated that the government is moving towards opening up the nuclear sector to the private sector.



#### Key Points:

##### India's Nuclear Sector

- Traditionally, nuclear power plants in India have been owned and operated solely by the state-owned Nuclear Power Corporation of India Limited (NPCIL) and its wholly-owned subsidiary, Bharatiya Nabhikiya Vidyut Nigam Limited (BHAVINI).
- To allow private sector participation, the government has proposed amendments to key laws:

--:13:-

- o The Atomic Energy Act, 1962, a framework for nuclear energy development and regulation.
- o The Civil Liability for Nuclear Damage Act, 2010, ensures compensation mechanisms for nuclear accidents.

## Government Steps

- India announced a ₹20,000 crore research and development mission for the development of small modular reactors (SMRs).
  - o India also aims to install at least five indigenously developed reactors by 2033.
- NPCIL and National Thermal Power Corporation (NTPC) have signed a supplementary joint venture agreement to develop nuclear power facilities in the country.
  - o The joint venture, named Ashwini, will build, own, and operate nuclear power plants, including the upcoming 4x700 MW PHWR Mahi-Banswara Rajasthan Atomic Power Project.

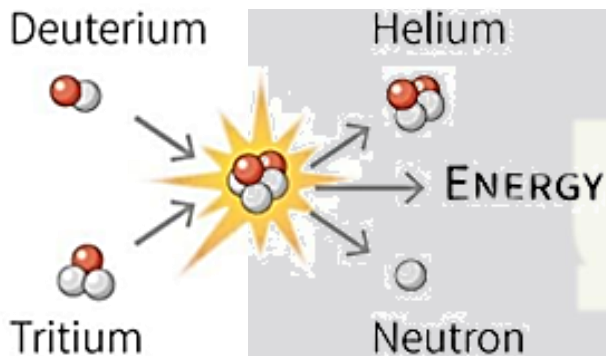

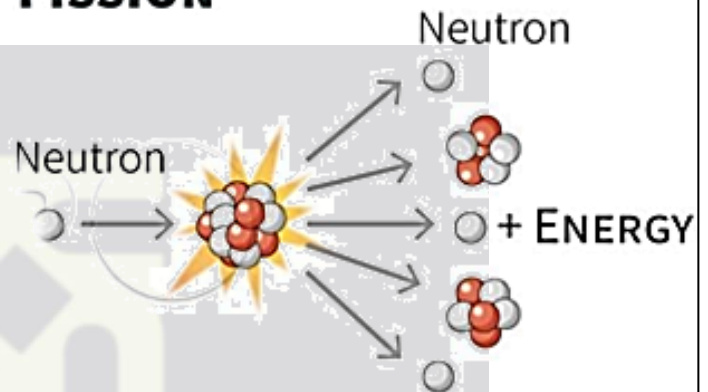
Nuclear reactions that produce massive amounts of energy, but have different processes

### Scheduled Tribe (ST) Status



#### Why in News?

- The Assam Group of Ministers (GoM) recommended granting Scheduled Tribe (ST) status to six communities.



#### Key Points:

- **The six communities:** Tai Ahom, Tea Tribes or Adivasis (Tea Tribes), Moran, Motok, Chutia, and Koch-Rajbongshi.
- These communities are currently listed in the Other Backward Classes (OBC) list of Assam. They constitute approximately 27% of the total population of the state.

#### Provisions relating to the granting of Scheduled Tribe status in the Constitution

- **Article 366(25):** According to this article, Scheduled Tribes (ST) are those communities notified under Article 342.
- **Article 342:** According to this article, the President has the power to notify the initial list of Scheduled Tribes. This list can be amended by Parliament through law.
- **Criteria for inclusion in the Scheduled Tribe list:** The Constitution does not clearly define any criteria for granting Scheduled Tribe status to a community.

#### However, the Lokur Committee (1965) suggested the following criteria:

- Characterized by a primitive nature
- Distinctive culture
- Geographical isolation
- Hesitation in contact with outsiders
- Backwardness

#### Why in News?

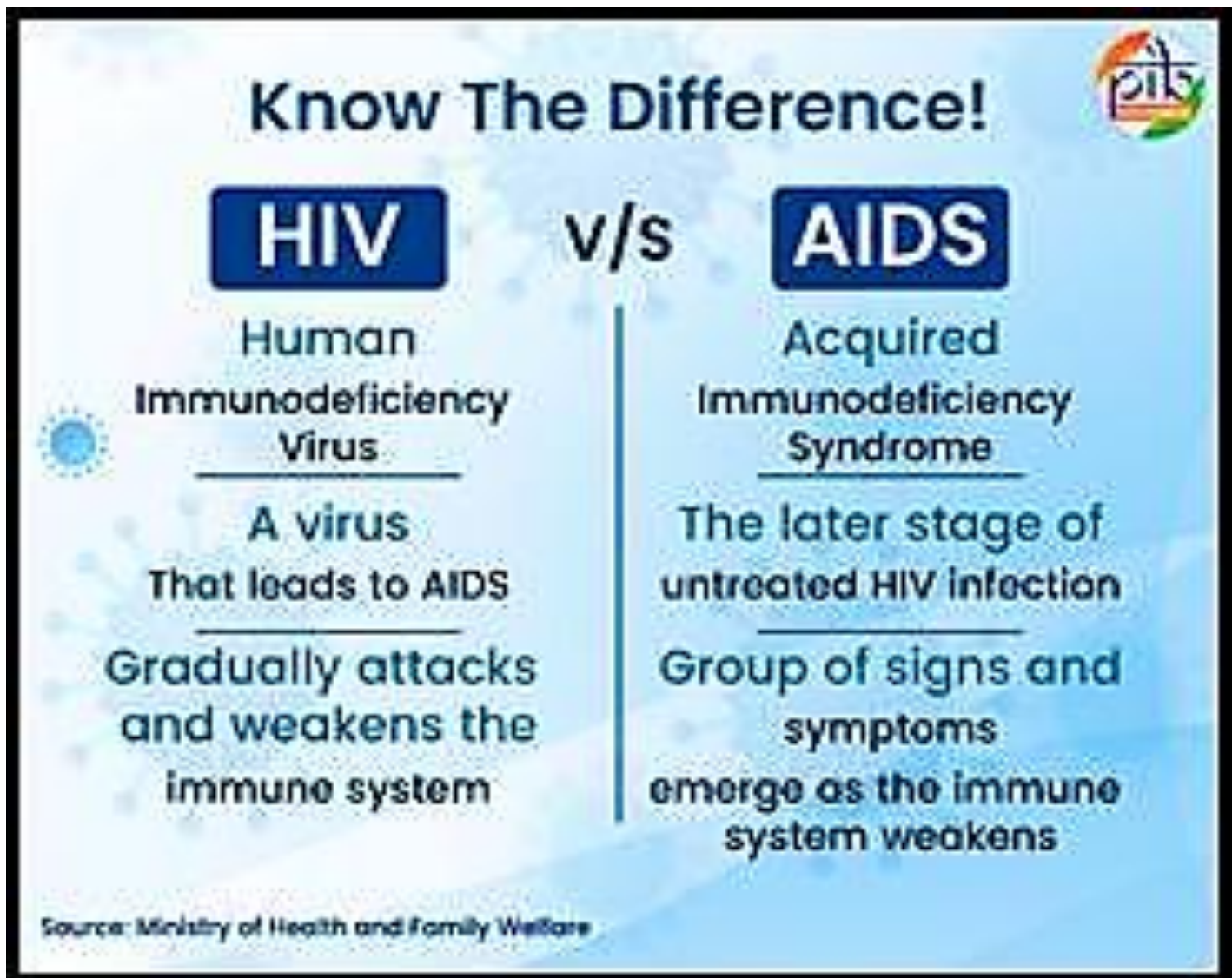
- World AIDS Day is observed every year on December 1.

#### Key Points:

- It was first marked by the World Health Organization (WHO) in 1988.
  - **Theme 2025:** Overcoming Disruption, Transforming the AIDS Response.
- HIV AIDS**
- Human immunodeficiency virus (HIV) is a virus that attacks the body's immune system.
    - o HIV targets the body's white blood cells, weakening the immune system. This makes diseases like tuberculosis, infections, and some cancers more likely to occur.
    - o Acquired immunodeficiency syndrome (AIDS) occurs in the most advanced stage of the infection.



## HIV/AIDS in India

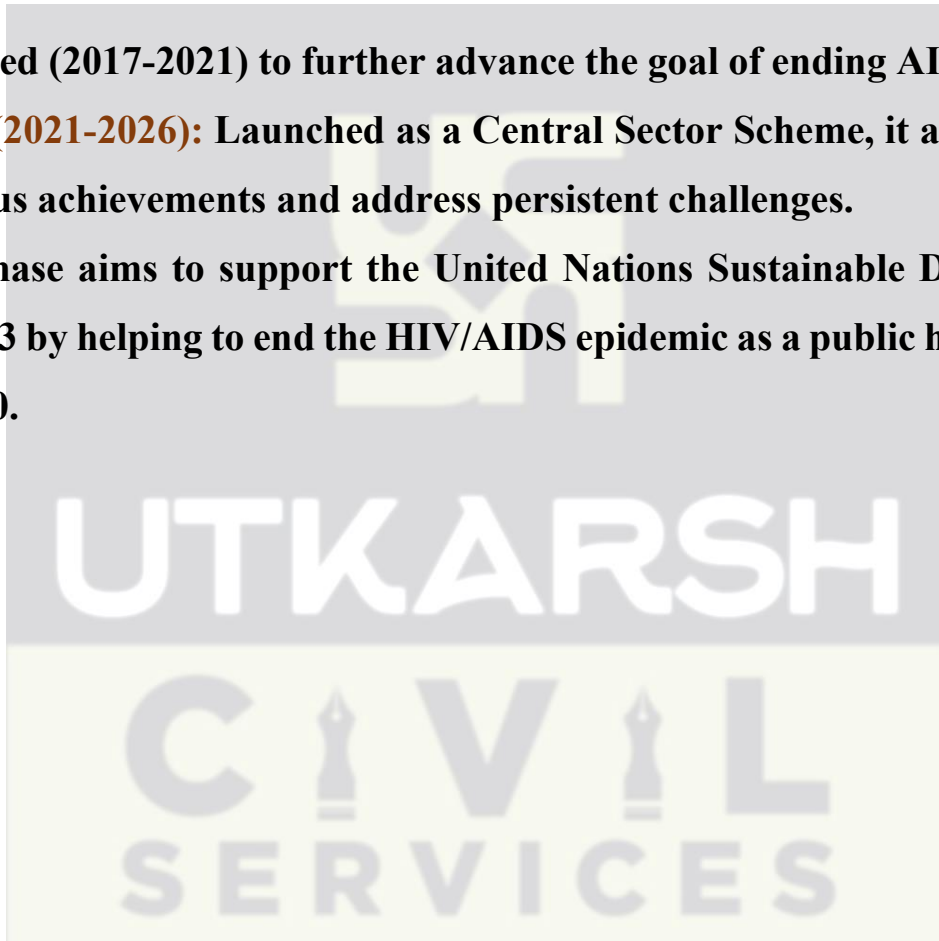
- Infections have declined from 0.33% in 2010 to 0.20% in 2024.
- This rate in India is significantly lower than the global average of 0.7%.
- New infections in India account for only 5% of the global total.

## National AIDS Control Programme (NACP)

- It has evolved in five phases, from basic awareness to comprehensive prevention, testing, treatment, and sustainability.
- **NACP I (1992–1999):** This was India's first comprehensive HIV/AIDS prevention and control program.



- **NACP II (1999–2006):** Strengthening long-term national capacity to combat HIV/AIDS.
- **NACP III (2007–2012):** Halting and reversing the HIV epidemic by 2012.
- **NACP IV (2012-2017):** 50% reduction in new infections (compared to a 2007 baseline).
  - o Extended (2017-2021) to further advance the goal of ending AIDS by 2030.
- **NACP V (2021-2026):** Launched as a Central Sector Scheme, it aims to build on previous achievements and address persistent challenges.
  - o This phase aims to support the United Nations Sustainable Development Goal 3.3 by helping to end the HIV/AIDS epidemic as a public health threat by 2030.
